4. **DO NOT ADD MUSIC! – we will do that – if you want to send us a sample for mood that's fine, but do not put music on your final submission!**
5. **BE AS CREATIVE AS YOU LIKE! Shoot inside, outside, costume, BE CREATIVE AND HAVE FUN!**
